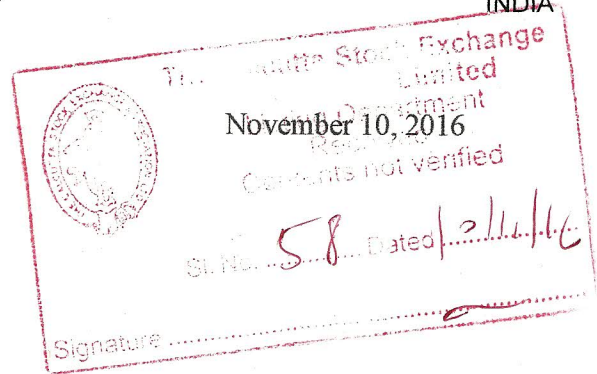

4. We invite your attention to the following:


